

## Appendix B - Asset Register

The RFO has reviewed fixed assets held by the Council at 31 March 2024 and restated the value to comply with the new valuation policy in Financial Regulations approved by the Council in November 2024.

This review included discussion with the Chair to ensure the asset register was complete and any assets no longer held by the Council were removed from the register. The RFO also reconciled the value of playground equipment to invoices in 2006/07 and examined purchase invoices from each year since 2006/07 to identify omitted assets.

Full workings will be provided at the May 2025 meeting but the summary is as follows:

There were no asset purchases or disposals in 2024/25. However, two allotment sheds were donated. The swings were repaired in Summer 2024 but only part of the assets was replaced (the seats).
